- a copy (photocopy is acceptable) of your 2019-2020 FAFSA (please note: preferential consideration is given to those whose reported annual family income is at or below 250% of the most recent annual federal poverty guidelines);
- a copy (photocopy is acceptable) of the results from your ACT and/or SAT examinations;
- a one-page résumé that outlines your work history, involvement in artistic or athletic activities, community service, and honors or awards;
- a brief essay (no more than 250 words) that describes your educational and professional goals and how your religious faith informs these goals.

Completed applications (including all supporting materials) should be submitted to Trinity Episcopal Church **no later than Wednesday – June 16, 2021**. Applications postmarked by this date are acceptable. Electronic submissions are acceptable, and can be sent to office@trinityepiscopal.church. Late or incomplete applications will not be considered.

I hereby certify that the information contained on this application and in all supporting materials is true and accurate to the best of my knowledge, and further acknowledge the following:

- that, in the event I am awarded a grant from the McConaughy Fund, my grant will be evenly divided over two equal installments, the first of which will be issued in early fall 2021, and the second of which will be issued in early spring 2022;
- that, in the event I am awarded a grant from the McConaughy Fund, I will need to maintain full-time enrollment status as well as both a current and cumulative grade point average of 2.0 or higher in order to be eligible to receive the full amount of my grant;
- that, prior to receiving any portion of any grant I may be awarded, I will need to submit a copy of my enrollment schedule for the up-coming semester along and will also need to submit a transcript of my grades for the fall semester prior to February 1, 2022, to receive the second half of my grant;
- that, in the event I am awarded a grant from the McConaughy Fund, I will apply the entirety of the grant to expenses directly related to my education;
- that, unless I am an active member of Trinity Episcopal Church, under no circumstances will I be eligible to receive more than two years (four semesters) worth of grants from the McConaughy Fund.
